 - Schedule 2013-2014 Board of Education Proposed Budget Submittal: Interim Superintendent K. Griffin, gave a Power Point presentation of the Board of Education's proposed budget for FY 2014-2015. Anticipated revenues are down by \$132,298 and expenses have increased by \$271,867. A tentative public hearing date was discussed for Thursday, May 1, 2014 at 7:00 p.m. in the Town Hall Municipal Gym.
