ALL PERSONS LIABLE TO PAY TAXES TO THE TOWN OF STERLING, CT ARE HEREBY NOTIFIED THAT THE FIRST INSTALLMENT OF REAL ESTATE, SEWER USE AND PERSONAL PROPERTY TAXES WILL BECOME DUE AND PAYABLE ON JULY 1, 2021 ON THE GRAND LIST OF OCTOBER 1, 2020 AT THE RATE OF 31.94 MILLS ON THE DOLLAR.

ALL MOTOR VEHICLE TAXES ARE ALSO DUE AND PAYABLE IN FULL ON JULY 1, 2021.

IF THE FIRST INSTALLMENT AND/OR MOTOR VEHICLE TAX IS NOT PAID ON OR BEFORE AUGUST 2, 2021, INTEREST WILL BE CHARGED ON SUCH DELINQUENT PAYMENTS AT A RATE OF 1 1/2% PER MONTH FROM THE ORIGINAL DUE DATE (JULY 1, 2021). MINIMUM INTEREST CHARGE IS \$2.00. ANNUAL INTEREST RATE IS 18%.

Please note: FAILURE TO RECEIVE A TAX BILL DOES NOT NEGATE THE TAX OR ANY INTEREST DUE ON SAID TAX SHOULD IT BECOME DELINQUENT
