**Item I:** Call to Order: The special meeting of the Sterling Board of Selectmen was called to order at 5:30 p.m. with Russell Gray, Lincoln Cooper, and John Firlik. Staff present-Joyce Gustavson.

Item II: Consider and Act on Plowing and Sanding Bids: The Board of Selectmen received the following two (2) bids for Plowing and Sanding for the 2017-2018 and 2018-2019 winter seasons: 1) Bill Gallup, 380 Valley View Road, Sterling, CT in the amount of \$100 per hour per truck, and 2) Steven Jordan, 1015 Gibson Hill Road, Sterling, CT in the amount of \$100 per hour per truck. J. Firlik made a motion, seconded by L. Firlik to award the bid to Mattern Construction, 26M Bushnell Hollow Road, Baltic, CT 06330 in the amount of \$16,517 for installation of cast in place concrete for Sumola Bridge cap replacement project. All voted in favor of the motion.
