Hall Expenses – Maintenance to retrofit the lighting at the Sterling Municipal Building, 1183 Plainfield Pike, Oneco and to vote to approve an appropriation in the amount of \$28,626 from the General Fund Balance to the Selectmen's 2017-2018 budget – Public Safety – Street Lights for the replacement of seventy-four (74) street lights with LED street lighting as approved by the Board of Finance.
