<u>Pledge of Allegiance</u>: Everyone stood to recite the Pledge of Allegiance.

Audience of Citizens: None.

<u>Approval of Minutes:</u> J. Firlik made a motion, seconded by R. Gray to approve the 12/6/2017 meeting minutes as presented. All voted in favor of the motion.

- **a. North Sterling Road Gravel Bank:** This application is scheduled to be received at the 1/23/2018 Zoning Board of Appeals meeting. J. Firlik made a motion, seconded by R. Gray to table this item to the next meeting. All voted in favor of the motion.
- **b.** Discussion Regarding Fracking Waste Ban: No new information. R. Gray made a motion, seconded by J. Firlik to table this item to the next meeting. All voted in favor of the motion.
- **c.** Retrofit Lighting at the Sterling Municipal Building, 1183 Plainfield Pike: No new information. J. Firlik made a motion, seconded by R. Gray to table this item to the next meeting. All voted in favor of the motion.

- **e.** Consider & Act on Appointment of Marlene Cook to Economic Development Commission: R. Gray made a motion, seconded by J. Firlik to appoint Marlene Cook, 541 Gibson Hill Road, Sterling, CT 06377 to a five (5) year term expiring 5/31/2022 to fill the vacancy of Cindy Donall to the Economic Development Commission. All voted in favor of the motion.
- **f.** 8-24 Referral for the Potential Sale of 91 Industrial Park Road, a.k.a. Lot #6: R. Gray reported he received a memo dated 12/28/2017 from Patricia Ball, Economic Development Coordinator, requesting the consideration of a referral from the Board of Selectmen to the Planning and Zoning

Commission for an 8-24 review of 91 Industrial Park Road, a.k.a., Lot #6. Terry Chappell, owner of Earth Retention Systems is interested in purchasing 91 Industrial Park Road for the appraised value in the amount of \$26,190. R. Gray made a motion, seconded by J. Firlik to refer the 8-24 Referral for the potential sale of 91 Industrial Park Road, a.k.a., Lot #6 to the Planning and Zoning Commission for review. All voted in favor of the motion.

g. Consider & Act on FY 2017 State Homeland Security Grant Program Region 4 Memorandum of Agreement Resolution: R. Gray made a motion, seconded by J. Firlik to adopt the following resolution:
