## January 16, 2019

The meeting of the Sterling Board of Selectmen was called to order at 6:00 p.m.

Selectmen present-Russell Gray, Lincoln Cooper, and John Firlik.

Staff present-Sherri Soucy and Joyce Gustavson.

Also present- David Shippee, Robert Salisbury, Elaine Lind, Ryan Linares, and Adam Teff.

<u>Pledge of Allegiance:</u> Everyone stood to recite the Pledge of Allegiance.

Audience of Citizens: No comment.

<u>Approval of Minutes:</u> J. Firlik made a motion, seconded by L. Cooper to approve the 1/2/2019 meeting minutes as presented. All voted in favor of the motion.

## **Unfinished Business:**

**a.** Commission Vacancies (Inland Wetland & Watercourses Commission, Economic Development Commission, and Planning & Zoning Commission): L. Cooper made a motion, seconded by J. Firlik to table this item to the next meeting as there are no candidates. All voted in favor of the motion.

## New Business:

- **a. Approval of Bills:** L. Cooper made a motion, seconded by J. Firlik to approve the bills for 1/10/2019 in the amount of \$29,538.90 and 1/15/2019 for \$9,995.70. All voted in favor of the motion.
- **b.** Solar Presentation by Titan Energy and Greenskies: Elaine Lind, Senior Account Executive of Titan Energy introduced Adam Teff, General Manager of Titan Energy and Ryan Linares, VP Real Estate of Greenskies. A. Teff stated that he consults with Greenskies as an energy consultant for electricity costs, while R. Linares is responsible for the design construct. R. Linares gave a presentation pointing out the potential energy savings for the Sterling Community School. The project requires zero (0) capital investment from the Town. The Town would purchase the energy generated on the roof for 0.069kWh flat for twenty-five (25) years. Currently the Town is paying +/- 0.13 kWh for energy. Eversource indicates this price will escalate by three (3) percent annually. J. Gustavson shall coordinate with the Board of Education and the Energy Commission to set up a meeting with Titan Energy and Greenskies to come back and present the solar project to both the Board and the Commission.
- c. Special Excavation Application by Canterbury Realty, LLC for Property Located at 76, 92, & 94 Sterling Road: R. Gray stated that the Planning and Zoning Commission at their meeting held on 1/15/2019 referred the Special Excavation Application for Canterbury Realty, LLC for property located at 76, 92, & 94 Sterling Road to the Board of Selectmen. Submitted for the record are preliminary comments dated 1/11/2019 from Don Aubrey, Town Engineer. A public hearing for Canterbury Realty, LLC has been scheduled for Wednesday, 2/6/2019 at 6:00 p.m. in Room #15 at the Sterling Town Hall/Municipal Building, 1183 Plainfield Pike, Oneco, CT.
- **d.** Consider & Act on Appointment of Representative to the Wood-Pawcatuck Wild and Scenic Rivers Stewardship Council: R. Gray reported that on 12/3/2018 he received a letter from Sean Henry, Chairperson of the Wood Pawcatuck Wild and Scenic Study Committee requesting that the Town of Sterling appoint one (1) representative and one (1) alternative to the Stewardship Council. Kim Gunn of the Sterling Inland Wetland and Watercourses Commission has agreed to serve as an alternative member to the Council. J. Firlik made a motion, seconded by L. Cooper to appoint Kim Gunn, PO Box 505, Oneco, CT 06373 as an alternative member to the Wood-Pawcatuck Wild and Scenic Rivers Stewardship Council. All voted in favor of the motion.
- e. Consider & Act on Desktop Computers, Monitors and Licensing Bids for Town Municipal Building: The Board of Selectmen received bids from the following five (5) companies for desktop computers, monitors, and licensing for the Town Municipal Building: 1) Howard Technology Solutions, 2) Saisystems International, Inc., 3) Savage Systems, LLC, 4) Southern Computer Warehouse, Inc., and 5) Spacebound Solutions. Each bidder had the opportunity to bid on six (6) components.
