The meeting of the Sterling Board of Selectmen was called to order at 6:00 p.m.

Also present-Ronald Sweet.

<u>Pledge of Allegiance:</u> Everyone stood to recite the Pledge of Allegiance.

<u>Audience of Citizens:</u> Ronald Sweet addressed the Board stating that he wants to construct a single-family dwelling on Margaret Henry Road. As it stands now, the driveway would be on the Town road. In 1992 the Town discontinued a portion of Miller Road running westerly from Margaret Henry Road. Miller Road would have reverted to the abutters, half to each. Mr. Sweet sold one lot but did not include the area of Miller Road, so the road is still with his lot. It is the consensus of the Board of Selectmen to have Mr. Sweet's attorney prepare a new description including the road and have it quit claimed back to himself.

<u>Approval of Minutes:</u> L. Cooper made a motion, seconded by J. Firlik to approve the 10/16/2019 meeting minutes and the 10/23/2019 special meeting minutes as presented. All voted in favor of the motion.

Cooper made a motion, seconded by J. Firlik to table this item to the next meeting as there are no candidates. All voted in favor of the motion.
- **b.** Consider & Act on General Office Assistant Position: Marnie Reynolds-Bourque, 286 Pine Hill Road, Sterling, CT 06377 was hired as General Office Assistant replacing Dale Boisselle who resigned effective 10/15/2019. L. Cooper made a motion, seconded by R. Gray to hire Marnie Reynolds-Bourque, effective 11/18/2019 as the General Office Assistant for twenty-four (24) hours per week at a rate of \$14.75 per hour in accordance with the existing policy as outlined in the Employee Handbook. R. Gray and L. Cooper voted yes. J. Firlik abstained. Motion carried.

Gray reported that the Recreation Authority did not have a quorum at their November meeting. L. Cooper made a motion, seconded by J. Firlik to table this item to the next meeting. Collelo, Jr., for property located at 92-94 Sterling Road. In August 2019, the property was sold to Canterbury Realty, LLC. L. Cooper made a motion, seconded by J. Firlik to release the cash surety bond for soil and erosion control in the amount of \$10,000 to Ernest J. Collelo, Jr., 446 Moosup Pond Road, Moosup, CT 06354 for property located at 92-94 Sterling Road. All voted in favor of the motion.
- **e.** Consider & Act on 2020 Schedule of Meetings: J. Firlik made a motion, seconded by L. Cooper to approve the 2020 Meeting Schedule. All voted in favor of the motion.
- **f.** Consider & Act on Increasing CIRMA Sterling Crime Limits: R. Gray reported that he received an email dated 10/24/2019 from Carol Fitzsimons of CIRMA (Connecticut Interlocal Risk Management Agency) requesting to increase Sterling Crime Limits from \$20,000 to \$50,000 or \$100,000. R. Gray made a motion, seconded by L. Cooper to increase the Town's Crime Limits from \$20,000 to \$50,000 for a total cost of \$1,089 for a three (3) year annual installment effective 12/2/2019. All voted in favor of the motion.
