- a. Commission Vacancies (Inland Wetland & Watercourses Commission, Northeast District Department of Health, Planning & Zoning Commission, and Zoning Board of Appeals): D. Shippee made a motion, seconded by P. Rabbitt to table this item to the next meeting as there are no candidates. All voted in favor of the motion.
- **b.** Discussion of Fuel Tanks Sterling Municipal Building, 1183 Plainfield Pike: No new information. D. Shippee made a motion, seconded by P. Rabbitt to table this item to the next meeting. All voted in favor of the motion.
- **c. Discussion Regarding Vendor for Fixed Assets:** L. Cooper reported that he has contacted the Connecticut Conference of Municipalities (CCM), Connecticut Council of Small Towns (COST) and Northeastern Connecticut Council of Governments (NECCOG) inquiring about vendors. - e. Discussion Regarding Propane Tanks Located at the Town Highway Garage, 215 Main Street and Water Pump Station, Sterling Road: The Board of Selectmen have received the following bids for one (1) 1,000 gallon propane take with regulators, 800 gallons of propane and installation of the concrete pad for the Town Highway Garage and one (1) 500 gallon propane tank with regulators and 400 gallons of propane for the Water Pump Station: 1) Hometown Heating, LLC in the amount of \$3,847 for the 1,000 gallon propane tank, \$1,560 for 800 gallons of propane, and \$1,020 for the installation of the concrete pad for a bid in the amount of \$6,427; \$2,200 for the 500 gallon propane tank, and \$780 for 400 gallons of propane for a bid in the amount of \$2,980, for a final bid in the amount of \$9,407; 2) Northeast Oil & Propane in the amount of \$3,673.50 for the 1,000 gallon propane tank and \$1,696 for 800 gallons of propane. No bid provided for the installation of the concrete pad for a bid in the amount of \$5,369.50; \$2,373.50 for the 500 gallon propane tank and \$848 for 400 gallons of propane for a bid in the amount of \$3,221.50, for a final bid in the amount of \$8,591; 3) Osterman Propane in the amount of \$4,302 for the 1,000 gallon propane tank. No bid provided for 800 gallons of propane for a final bid in the amount of \$6,630; \$2,680 for the 500 gallon propane tank. No bid was provided for 400 gallons of propane for a final bid in the amount of \$9,310. D. Shippee made a motion, seconded by P. Rabbitt to award the bid for the purchase of one (1) 1,000 gallon propane tank with regulators, 800 gallons of propane, the installation of the concrete pad for the Town Highway Garage located at 215 Main Street, and one (1) 500 gallon propane tank with regulators and 400 gallons of propane for the Water Pump Station, Sterling Road to Hometown Heating, LLC, 549 Wolf Den Road, Brooklyn, CT 06234 in the amount of \$3,847 for the 1,000 gallon propane tank, \$1,560 for 800 gallons of propane, \$1,020 for the installation of the concrete pad, \$2,200 for the 500 gallon propane tank, and \$780 for 400 gallons of propane for a final bid in the amount of \$9,407 pending Board of Finance approval. All voted in favor of the motion.
