Rabbitt to hold the Annual Town Meeting on Wednesday, June 16, 2021 at 7:00 p.m. in Room #15 at the Sterling Town Hall/Municipal Building to act on the reports of the town, authorize borrowing for the ensuing year, and designate banks for town depositories. All voted in favor of the motion.
