## **Unfinished Business:**

- **a.** Church Street Town Owned Property: D. Roussel made a motion, seconded by C. Bein to table till we receive an appraisal from Russ Appraisal Services. All voted in favor of the motion.
- **b. Phase II Industrial Park Parcel**: R. Bein presented that she has emailed Valentina Solomita from Pure Hedge LLC with contact names and phone numbers for V. Solomita to contact in the State. R. Bein followed up with V. Solomita, R. Bein is waiting to hear back from V. Solomita. D. Roussel made a motion, seconded by S. Blinkhorn to table this till further notice. All voted in favor of the motion.
- **c.** Industrial Park Lot #13: Dana Peloso presented an offer on behalf of Jeff Joslyn to purchase Industrial Park Lot #13. R. Bein presented the email from D. Peloso. R. - d. Discussion Regarding the Sale of 11.7 +/- Acres of Vacant Land for Property Located at 0 Plainfield Pike Independently from the Sale of 1110 Plainfield Pike a.k.a. Old Town Library: R. Bein has been in contact with Attorney Kari Olson from Murtha Cullina, LLP and Demian Sorrentino with Boundaries, LLC about the easement for 1110 Plainfield Pike property. D.
