**Approval of Previous Meeting Minutes:** D. Roussel made a motion, seconded by S. Hebner to accept as written the previous meeting minutes with an amendment that Mark Jordan was not an EDC member at the time of the August's meeting. All voted in favor of the motion.

## **Unfinished Business:**

- **a.** Church Street Town Owned Property: R. Bein read an email from Demian Sorrentino, there was discussion. D. Roussel made a motion, seconded by J. Andrade to have Demian Sorrentino, the town approved Real Estate Agent, to market the 0 Church Street town owned property of 28 +/- acres for \$90,000, that was the appraised list price and not to be firm on this amount. - **d. Rental of the Cell Tower, Lot #16:** After discussion, R. Bein provided the monthly rent and will forward the 2006 current Lease to Attorney Michael Zizka from Halloran & Sage LLP, of the cell tower.
- **e. Security Cameras in the Industrial Park:** R. Bein has met with Kipp Bellavance in the Industrial Park at the Incubator Building, he submitted a bill of \$3,536.03. There was discussion. D.
