**Approval of Previous Meeting Minutes:** R. Farrugia made a motion, seconded by Mark Jordan to accept, as written, the June 13<sup>th</sup>, 2023, regular meeting minutes as presented. All voted in favor of the motion.

## **Unfinished Business:**

a. Leases/Documents for the Incubator Building: R. Bein mailed the commission copies of the two leases; Detotec & Westmark and a copy of the Grant paperwork that was used for the Incubator Building. R. Bein has been in contact with Michael Baker of Westmark, he is on vacation and will not be attending this meeting. M. Baker will be attending next month's monthly meeting. Tim O'Brien spoke, mentioning he does store plastics, equipment, plastics that are used for manufacturing, and some furniture in the Incubator Building. The commission asked questions. There was a discussion. R. Farrugia made a motion, seconded by Mark Jordan to table till next month's meeting. All voted in favor of this motion.

b. **Covenants, 2 Properties of Pure Hedge:** R. Bein reported to the commission that she did not write a letter to send to Valentina Solomita per the previous monthly meeting's motion. The two pieces of properties; 10 acres on Sterling Road and 61.18 acres on Main Street, these properties owned by V. Farrugia to accept, and move forward with the letter of interest as presented for the balance of Lot #16 minus the 40,000 square feet, pending on a Site Map.
