- **g. Public Works Report**: L. Cooper explained the Highway crew have done drainage work on Saw Mill Hill RD, mowed and cut back intersection corners, apron work has been done.
- h. Discussion regarding 29 Industrial Park Rd N Building a 1.3 +/-MW solar Farm. Guy Mozzicato Manager of ATMA Investments, LLC presented to the Board a letter of interest to purchase 29 Industrial Park Rd N. Several questions were raised. Isn't the Industrial Park's mission to make money for the town and provide jobs? A solar array would provide no benefit for the Town, may possibly lose tax revenue on parcel. These panels would be next to the Sterling Height Development, solar panels do make noise and generate heat. There is a possible lot line adjustment which would involve hiring an attorney. Does this proposal fit the overall Industrial Park? The consensus of the Selectmen were not in favor of this proposal. Many more questions need to be asked of the Economic Development Commission regarding this. D. Shippee would like to know if Phase One is not complete, why is the Commission looking to hire a surveyor for Phase Two?
