## **Old Business:**

- Attorney
  Heller states that when the new permit was issued in 2018 for this project,
  there was a State Statute, 8-3, that extended these permits for fourteen
  years, therefore, a renewal is not necessary at this time. The Town
  Attorney was contacted today but requested time to research this Statute.

  J. Larkin shared motions made by the Board of Selectmen in 2018
  regarding this application. It was stated at the last meeting, DOT approval
  was given for the new driveway into the property, however, a letter from
  DOT given to members states it was not approved. The board agrees they
  would like to wait for the Town Attorney's opinion.

- b. Fee Schedule Ordinance discussion and possible action: ZEO V. Robinson-Lewis provides the board with proposed fees for land use applications as requested. The board would like to see non-residential listed to avoid conflict of the building departments fees. These fees would become an ordinance that would need to be approved at a Town Meeting.

J. McLevy made a motion to forward the proposed land use application fees to the Board of Selectmen for approval with no additional comments or concerns from this board. J. Angelone seconded the motion. Motion carried 4-0.
